TNTPO has decided the following regarding the cancellation / re-schedulement / delayed penalty due to COVID-19 Pandemic for the events to be organised by Third Party Fairs Organisers in the Financial year-2021-22 at Chennai Trade Centre.

- 1. One time reschedulement for the events to be held in the FY 2021-22 without any reschedulement charges, subject to the condition that the request is received in TNTPO 30 days prior to the start of the tenancy and the event is to be shifted within the current financial year only, i.e., FY 2021-22.
- 2. Not to charge the penalty on the delayed payment for the period Jan 01, 2021 to March 31, 2021, or till 15 days before the start of the tenancy of the event, whichever is earlier, for all the approved events scheduled to be held during the FY 2020-21 and FY 2021-22. (In case, the payment is received by TNTPO after March 31, 2021, the delayed penalty for the entire period will be charged, i.e, Feb 01, 2021 to March 31, 2021)
- 3. On reduction in area, TNTPO will charge 10% of the actual applicable penalty for the approved events scheduled to be held during the first two quarters (April to June & July to September) of the FY 2021-22.

However, on cancellation of their event(s) scheduled to be held during the first and second quarters of the FY 2021-22, TNTPOs will have two options:

i). Credit note equivalent to 100% advances with TNTPO will be issued for their future bookings / adjustments. In case, the organiser has deposited extra amount over and above the actual applicable 100% penalty, the excess amount can be refunded on request after converting the applicable penalty amount in the credit note.

OR

ii). In case of TNTPOs opting for refund (not credit note for any amount), all advances with TNTPO will be refunded to the organiser after deducting 25% only of the actual applicable penalty.

However, on cancellation of their event(s) scheduled to be held during the third and fourth quarters of the FY 2021-22, there will be no option of credit note and TNTPO

will charge 50% of the actual applicable penalty and the rest of the amount with TNTPO will be refunded.

- 4. On reduction in area, TNTPO will charge 20% of the actual applicable penalty for the approved events scheduled to be held during the FY 2021-22.
- 5. TNTPO will give relief of 10%, 5%, 2.5% and 'Nil' on the published/approved rentals to the third party fair organisers for the events booked/to be or re-scheduled/to be rescheduled during the first, second, third & fourth quarters respectively for the FY 2021-22.
- 6. To consider rescheduling of payment terms to a period of 4 months from existing 8 months prior to the start of the tenancy of the events scheduled for the first and second quarters of the FY 2021-22, for the events not covered under the Revised Rentals for TNTPOs order dated Jan 12, 2021".
