Sealed tenders are hereby invited on behalf of Tamil Nadu Trade Promotion Organisation, Chennai from Industry owners, Scrap Dealers, Individuals and others who are interested in buying Plastic Scrap, Steel Scrap, Copper Scrap, Wood Scrap & Paper Scrap.

The details are as summarized below:

b)	Procedure for quoting price	The offer price shall be quoted for each category of the scrap (as detailed on above at Para ‘a’ of this table) as per their relevant units on “as is where is basis”, as per the format attached at annexure A. The tender shall be awarded based on the highest offer received for individual stock. In other words, the successful bidder would be decided for each item based on the highest offer received for particular item.

INSTRUCTION TO THE TENDERERS

The tender shall be submitted in accordance with these instructions and any tender not confirming the instructions as under is liable to be rejected. These instructions shall form the part of the tender and contract.

1. The tender should be submitted in **sealed cover** super scribed as “**SALE OF PLASTIC SCRAP, STEEL SCRAP, COPPER SCRAP, WOOD SCRAP AND PAPER SCRAP**”.
2. In case Tender Document is downloaded from the website, the cost of Tender Document i.e. Rs. 250/- (Rupees Two Hundred and Fifty only) + GST @ 18% should be enclosed with the Tender by way of Demand Draft in favour of “TAMILNADU TRADE PROMOTION ORGANISATION” payable at Chennai.
3. The tender shall be submitted along with the Demand Draft for Rs. 5,000/- (Rupees Five Thousand only) towards Earnest Money Deposit in favour of “TAMILNADU TRADE PROMOTION ORGANISATION” payable at Chennai.
4. The Tender shall be completed in all respect and should be signed with date by Authorized Signatory of tenderer on all the pages.
5. The offer price shall be quoted for the scrap as per their relevant unit basis on “**As is where is Basis**” as excluding government taxes and duties.
6. The Tenderers are free to inspect the Scrap at the Tamil Nadu Trade Promotion Organisation, Nanadambakkam, Chennai – 600 089 from 10:00 AM to 05:00 PM on any working days from Monday to Friday i.e. from 24.10.2018 to 30.10.2018.
7. The tender shall be awarded based on the highest offer received for individual item / stock. In other words, the successful bidder would be decided for each item based on the highest offer received for particular item. Accordingly the delivery of each item would be issued separately to selected bidder for that particular item.
8. Procedure for disposal of Scrap:
 - a. The successful Tenderer i.e. H1 shall deposit a lump sum amount including GST in Rupees for individual category of scrap as detailed under by way of Demand Draft in favour of TAMILNADU TRADE PROMOTION ORGANISATION towards the cost of scrap (approx.) within five working days from the date of awarding the order.

The details of lump sum amount to be paid for individual category of scrap shall be calculated as per the formula as under;

Amount in Rupees for the lump sum payment = (Approx. quantity as indicated in column No. 2 of under table) Multiply (the offer price quoted by you through this tender).

The approximate quantity for individual category of scrap is given in the table under:

- b. It may be noted that the quantity as mentioned above against individual category of scrap shall be considered as approximate quantity but the actual payment would be calculated on the basis of actual quantity of scrap to be lifted. In case the actual quantity is less than the quantity mentioned above para, the balance amount out of the lump sum amount paid would be returned. If any excess amount to be paid, it should be paid within three working days.
- c. The truck / tempo for Scrap lifting and carrying shall be arranged by tenderer at their cost. The tenderer shall have to make arrangement for loading of scrap to truck / tempo at their cost and TNTPO will not pay any charges for the same.
- d. Prior to the loading of scrap on the Truck / Tempo, the empty Truck / Tempo shall be taken to the Weighing Bridge for weighing in presence of official from TNTPO
- e. The loaded truck would again be sent to the weighing scale for weighing, and the weight of material would be calculated for payment of quantity of scrap based on the quoted price. The Weighing Bridge will be decided at random by TNTPO officer.
- f. While lifting the scrap, the successful bidder should not damage the property of TNTPO. Damages, if any is caused should be compensated by the bidder, the amount of which shall be determined by the Managing Director, TNTPO.

Sealed Tenders are hereby invited for disposal of Plastic Scrap, Steel Scrap, Copper Scrap, Wood Scrap and Paper Scrap on “As is where is basis”. The Scrap is available for disposal at Tamil Nadu Trade Promotion Organisation, Nandambakkam, Chennai – 600 089 as per the following terms & conditions:

1. Tenderers shall submit their offers in a sealed cover superscribed as “Tender for the sale of Plastic Scrap, Steel Scrap, Copper Scrap, Wood Scrap and Paper Scrap” at TNTPO (Category I) on or before 31.10.2018 up to 03:30 PM
2. The tender should be accompanied with the Earnest Money Deposit of Rs. 5,000/- in the form of a Demand Draft “TAMILNADU TRADE PROMOTION ORGANISATION” payable at Chennai. No Cheque or cash shall be accepted. The offers without Earnest Money Deposit will be rejected.
3. Tenderers shall take into account the cost of labour, loading & cartage etc for taking delivery from the premises of TNTPO before quoting the rates, In this regard no claim what so ever shall be entertained by the TNTPO and shall hand over the scrap to successful tenderers on the place where it is actually lying presently in the Campus.
4. The successful Tenderer shall bear the cost of weighing the empty & loaded Truck / Tempo.
5. TNTPO officer shall accompany the Truck / Tempo arranged by the successful tenderer for weighing. The weighing bridge selected by TNTPO officers for weighing the empty / loaded truck / tempo shall be binding on the Tenderer. The empty Truck / Tempo shall be directly brought to the Centre after weighing.
6. The Managing Director, TNTPO reserves all the rights to accept or reject any or all the offers. The decision of the TNTPO will be final and binding on the Tenderers.
7. The tenders will be opened at TNTPO on 31.10.2018 at 04:00 PM. The Tenderers or their authorized representatives (one person only) may be present at the time of opening of the tender.
