All installations shall also comply with the requirements of Indian Electricity Rules 1956 with amendments upto date. In case of items not covered by the above specifications, the work shall be carried out as per the instructions of the Engineer-in-charge and as per relevant standards.
- 2. The prospective tenderer is advised to visit the site before quoting for the work and no claim whatsoever on account of any deficiency at site shall be entertained including security restrictions, inaccessibility, local by-laws/rules.

- 3. All components used shall conform to relevant Indian Standard Specification. Wherever existing, materials with ISI certification mark shall only be used.
- 4. All the materials to be used in the work shall be got approved by the Engineer-in-charge before their actual use in work.
- 5. Bad workmanship shall be rejected in toto.
- 6. All the debris due to the electrical work shall be cleared every now and then, and site shall be kept clean by the contractor at all times.
- 7. The Contractor has to make his own arrangements for the watch and ward of the materials and other installations till the installation / work is completely handed over to the department. No extra claim will be entertained on account of this. Any damage caused to the material during or under storage will be to the Contractor's account.
- 8. The Contractor shall make his own arrangement for all general and special T & P required for the work.
- 9. The Contractor should purchase the materials to be used in the work directly from the authorized dealer / manufacturer and the contractor should preserve the proof of the same, i.e delivery challan, proforma invoice, bill etc. till the completion of work and has to produce the same in case the Engineer in charge demands for to check the genuinety of the materials.
- 10. The prices quoted shall be inclusive of all taxes, duties and GST. The GST, Labour welfare fund and income tax rates as applicable will be deducted at source from the contractor's bills and will be remitted to the concerned authorities. The rates of above taxes however are subjected to revision from time to time and nothing extra will be paid to the contractor on this account.
